Restart Energy Democracy Carbon Standard Fee Schedule

This document consolidates all the charges associated with the products and services provided under the RED Carbon Standard, outlining to whom it is addressed and the corresponding rate for each charge.

It's important to remember that developers, owners, and various market participants subject to the fees, use the most recent version when requesting services from the RED Carbon Standard or completing payments.

This document will undergo periodic updates, subject to approval by the Board of Directors, which may involve rate changes or the addition of new ones.

Useful information:

- For retroactive projects, project developers will receive carbon certificates for a period of 1 year retroactively.
- Retroactive projects are those with a start date no more than one year prior to the date of project announcement for RED Standard Certification.
- Monitoring/verification periods can be done monthly, half of the year, yearly or for larger periods of time, as per project developer choice, and at least once every 3 years.
- Non-AFOLU - is defined as a greenhouse gas inventory sector that covers emissions and carbon reduction projects resulting from renewable energy, waste handling and disposal, etc.
- AFOLU - is defined as a greenhouse gas inventory sector that covers emissions and removals of greenhouse gases resulting from direct human-induced land use such as settlements and commercial uses, land-use change, and forestry activities. AFOLU projects fall under the following categories: Afforestation, Reforestation and Revegetation (ARR), Agricultural Land Management (ALM), Improved Forest Management (IFM), Reduced Emissions from Deforestation and Degradation (REDD), Avoided Conversion of Grasslands and Shrublands (ACoGS), Wetlands Restoration and Conservation (WRC).
 - Micro-scale projects are from 0 – 10.000 tCO₂ emission reduction/removals
 - Small scale projects are from 10.000 – 60.000 tCO₂ emission reduction/ removals
 - Large scale projects are > 60.000 tCO₂ emission reduction/removals
